NA KĀNĀWAI NUI NO KA ʻĀINA O LILIʻUOKALANI Rules and Polices for Use of Keahuolū Campgrounds

The Trustees of Lili'uokalani Trust have set aside this site for the benefit and enjoyment of Hawaiian/Part-Hawaiian children. The rights and well being of our beneficiaries and their families using the ʻaina should be carefully observed. Aloha and all the courtesy it stands for is the main Kānāwai Nui.

For our beneficiaries and their families using the ʻaina, the responsibility for and supervision of our beneficiaries rests with their parents or guardians who accompany them. **Minors must be supervised at all times.** Please exercise common sense and courtesy while sharing the ʻaina with others.

Registered parents or guardians are responsible for beneficiaries and for any others that join them during time of use of Lili'uokalani Trust (LT) land. LT facility and camping policy requires names and vehicle information of all parties who will be on LT property and only those parties and vehicles provided to LT during use will be allowed at campgrounds. LT has the right on short notice to terminate any permit or camping registration at any time, with or without cause.

The Following Constitutes the Na Kānāwai Nui No Ka ʻĀina O Lili'uokalani:

1. On day of arrival, check-in and pick-up the gate transmitter at Lili'uokalani Trust 74-5490 Makala Blvd, Kailua Kona, HI 96740. Office hours: 8am to 4pm, Mon – Fri, closed Weekends and Holidays.
2. **Weekends and Holidays:** Check-in is by appointment only. Appointments must be made during office hours listed above. Weekend and Holiday appointments will be scheduled between 8:00am – 11:00 am. Please call (808) 238-3120 to schedule an appointment.
3. **Campsite check in is at 8:00am, and check out is at 4:00pm. On day of departure, drop off gate transmitter, parking permit, and Lawai'a Report into the black drop box on the outside of main gate. Unreturned property will result in suspension of camping privileges.**
4. Once checked in, there will be **NO** revisions to your guest list and vehicle information.
5. Only individuals and vehicles provided at check in, are allowed on the premises. Our camping policy requires the first and last names of all parties who will be entering the property along with the make, model, color and license number of all vehicles and trailers.
6. Trailers are required to park in the Pono Parking lot.
7. **LT enforces a zero-tolerance policy. Alcoholic beverages, the possession or use of illegal drugs, being under the influence of alcohol or illegal drugs, gambling, and other illegal activities are prohibited on Trust property.**

8. **Campsite capacity & ratio:** 1 registered child = 4 guests, 2 registered children = 5 guests, 3 registered children = 7 guests (maximum of 10, **ONLY** if your ohana meets the child to guest ratio).
9. Please **respect all graves, artifacts and archaeological sites**. Please do not damage, remove, or destroy any artifacts or sites that are found. Please notify LT staff as soon as possible if an artifact is discovered or a site becomes damaged in any way.
10. Please remember to **remove and take out everything that you bring in, including trash**. We do not supply trash containers or bins.
11. Firearms (including pellet, b-b guns, air rifles, and pneumatic spear guns), fireworks or other incineratable material are prohibited on Trust property. Hunting or trapping of animals is prohibited.
12. **Bonfires are prohibited**. Campfires are not allowed on lawn area. They are only allowed in designated areas where fire pits and barbecue grills are provided. As a precaution:
 - a. Maintain a 10-foot radius, clear of burnable material, around the campfire.
 - b. Keep campfire under control at all times, with water or sand on hand in case of emergency.
 - c. Campfires should always be monitored by an adult and never left unattended. Please extinguish fire completely after use.
 - d. Use only dead materials, i.e., twigs or leaves on the ground, for firewood. Campers are to provide their own fuel (charcoal, wood).
 - e. The burning of wooden pallet racks is prohibited.
13. Please do not damage plants or trees on the property. Do not hammer nails into trees when setting up your campsites; you may secure tents and tarps by tying rope or twine to tree trunks, branches or stones. Please remember to remove and take with you all rope or twine or other materials that you use before leaving the campsite.
14. **No pets** or other animals are allowed on the premises.
15. Fishing is allowed only in the ocean (not the anchialine ponds). **Please take only what your family will eat during your stay**.
 - a. After fishing, **please fill out the Lawaiʻa Report** as part of our on-going study towards marine stewardship.
 - b. Do not clean and dispose of fish waste in swimming areas.
 - c. Please use caution when fishing.
16. All ponds located within the Halepaʻo Campgrounds are off limits, except when accompanied by LT staff.
17. Adhere 15 miles per hour speed limit within Trust property. Keiki at play.

18. Park only in areas designated as parking areas (5 stalls at Halepaʻo and designated area at Hiʻiakanoholae). Display the parking permit on the rear-view mirror of each vehicle. Vehicles are to be operated by licensed individuals and are not to be driven on the campsites. All terrain vehicles (ATVs), dirt bikes, motor scooters, etc. are prohibited.
19. Please clean utensils in designated areas. Keep campsites clean.
20. Lua facilities are located at each camp kipuka. Campers are expected to use them to help safeguard the sanitation of the camps. Halepaʻo has a composting toilet facility to help conserve precious wai (water) and to re-use the byproduct to create nutrient rich soil. Please kokua and **do not throw anything into composting toilets besides toilet paper and composting wood shavings.**
21. Each family is limited to 2 reservations per calendar year.
22. Camping is authorized only in designated areas.
23. Please do not remove picnic tables from camp areas.
24. The campgrounds will be **closed every Tuesday and Wednesday** to allow replenishment and maintenance procedures to occur.
25. Suggestions to Liliʻuokalani Trust representatives regarding modification to the campsites or ideas on how to make your camping experience more enjoyable are welcome.
26. Liliʻuokalani Trust property at the Keahuolū Campgrounds is to be used strictly for recreational purposes without compensation to the Trust as camping grounds are for beneficiaries, their families, and their guests, or other designated organizational use. Liliʻuokalani Trust has the right on short notice to terminate any permit at any time with or without cause.

The above rules and conditions are to protect and preserve the ʻāina and to ensure the peaceful enjoyment for all who share the ʻāina now and into the future.
